12:00 Item 1. Peer learning – best practices and lessons learned on TOSSD reporting

At the 16th Task Force meeting, members welcomed peer learning as a tool to facilitate reporting. Members are invited to identify ahead of the meeting best practices and key lessons learned from their reporting experience that they would like to share with the Task Force (e.g., on how to expand the coverage of activities, how to improve the quality of reporting on specific fields such as the SDG focus or the pillar attribution of activities). Members are also invited to identify one or more key questions related to reporting, and ideally send them in advance by 13 October to the Secretariat. **The session will consist of a “tour-de table” where Task Force members will share these best practices and lessons learnt, and ask their key questions on reporting.**

The Secretariat will provide an update on the ongoing data pilot on institutional investors and present the key messages and findings from a recent OECD Report on Philanthropic flows. **Members will be invited to share their views on the progress of the pilot and on the report presented.**

In addition, footnote 30 in paragraph 89 of the May 2022 version of the Reporting Instructions indicates that "further work on formatting keywords will be considered for subsequent revisions to the Reporting Instructions" in relation to reporter-driven keywords. The Secretariat will present proposals regarding these issues, and **members will be invited to review and comment on them.**
