ALL ABOUT TOSSD

What is TOSSD?

- 븆 TOSSD is an acronym: Total Official Support for Sustainable Development
- TOSSD is shorthand for "an international standard for measuring the full array of resources to promote the sustainable development of developing countries".
- **TOSSD is a universal statistical framework** for all public providers, both countries and international organisations.
- **TOSSD** is a transparency tool to improve the effectiveness of development support, promoting co-ordination and ownership, and encouraging dialogue between stakeholders.
- **TOSSD is a recognised standard** an objective methodology, jointly created by a wide range of stakeholders, guaranteeing the highest data quality for decision making.

What does TOSSD do?

The SDGs call for a holistic approach to measuring support for developing countries, and TOSSD fulfils this need.

- It monitors all official resources flowing into developing countries for their sustainable development
- 🖊 It monitors private resources mobilised through official means.
- 븆 It measures contributions to International Public Goods
- By providing a unified statistical framework, **TOSSD avoids the problem of having to collate many different sets of data**, facilitating the comparison and use of information.
- **TOSSD can serve as a source for evidence-based decision making** at all levels, to showcase the progress in achieving the SDGs and other international commitments.
- TOSSD considers the dynamic nature of the international development finance landscape and its various players and financing mechanisms. This makes TOSSD a useful and valuable tool for planning and monitoring sustainable development activities at the national and international levels.



THE INTERNATIONAL FORUM ON TOSSD AND ITS ORIGINS

The International Forum on TOSSD ('IFT' or 'Forum') has its origins in the **Addis Ababa Action Agenda, 2017**. Traditionally, developing countries did not have a say on the measurement of development finance. To address this, the International TOSSD Task Force was set up, in 2017, to develop the TOSSD standard. The Task Force was a large, diverse group of experts from traditional and dual provider/recipient countries, recipient countries and international organisations.

The Task Force was included in the Programme of Work and Budget of the OECD and governed by the OECD Development Assistance Committee. Over time, as Task Force membership grew together with their ambitions for TOSSD, it became clear that the Task Force needed its own governance structure and independence, and so, **on 1 January 2024, the Forum was created**.

The Forum:

- oversees the TOSSD standard;
- is an independent governing body with a balanced representation of provider and recipient countries;
- 4 is committed to open, inclusive and transparent discussions on TOSSD.

In a nutshell, the Forum:

- maintains and improves the TOSSD standard;
- ∔ collects and analyses TOSSD data;
- promotes TOSSD worldwide.

THE INTERNATIONAL FORUM ON TOSSD AND ITS GOVERNANCE


The Forum is an independent entity whose Secretariat is hosted by the OECD for administrative purposes.
